9. That the Management of the school shall create a Reserve fund equal to minimum three months salary of the staff in the joint name of the Director of Education and the Manager of the school.
10. That the arrangement of good drinking water shall be made available to all the students/teachers and sanitary facilities shall also be provided to the students immediately.
11. Fresh Health certificate may also be obtained from M.C.D. within a month and submitted to the Education Officer for verification.
12. That the enrolment in each section shall not exceed the number of students calculated @ 10 sq. ft. per student for the available floor area of the class room and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education, Delhi, in each class. Number of the existing sections should not exceed the number of class rooms of proper size in the school.
13. That Govt. Nominee in the Managing Committee will be asked immediately and all decisions will be taken in accordance with the provisions in the approved Scheme of Management by the D.D.E. (ACT).
14. The Managing Committee of the school shall not enhance the fee during the ensuing academic session without the prior approval of the Director of Education which is a mandatory requirement under sub-section (3) of Section 17 of Delhi School Education Act, 1973 and shall regulate the functioning of the school strictly in accordance with the provisions of the Act and Rules.
15. IXth class should not be started without the prior approval of the Director of Education.
16. That the violation of any instructions/orders/conditions/rules and regulations of the Department shall lead to the withdrawal of recognition of the school.
17. That a report about the fulfilment of the above conditions giving the extent to which each condition is fulfilled shall be sent to the Education Officer within six months.

10. Fresh Health Certificate from the MCH is obtained and produced to Education Officer for verification.
11. The Management of School will obtain land from DDA, if already not obtained, in the name of the Society through Director of Education, Delhi and shall construct the school building thereon the school as per specifications of the Department within a period of two years. That adequate and sufficient accommodation of 10 sq. ft. per student shall be provided for the class room and shall be not less than 100 sq. ft. area.
12. That proper facilities for drinking water, latrine and first aid be provided, separate toilets for boys, girls and separate toilets for ladies and gents shall be also provided.
